Southern Downs Regional Council has Public Liability Insurance coverage for Leslie Park and the Warwick Potters' Association is covered for coordinating the Craft Market and their own stall. ALL STALLHOLDERS are required to have their own Public Liability Insurance. You must attach a current 'copy of renewal', 'receipt' or 'broker's certificate' with your stallholder application form.

FOOD LICENCE -

If your business requires a food licence, please attach a current copy with your stallholder application form.



TEMPORARY FOOD LICENCE -

If you are a temporary food stall and wish to prepare food on site, you will be required to have a 'temporary food licence' available from the Environmental Services Department of the Southern Downs Regional Council prior to the event. This will need to be attached to your stallholder application form.

POWER-

Please indicate in DETAIL the number and type of power required as outlets are LIMITED. Extension cords may be necessary and must be tagged and tested. Gas and electrical equipment should be checked prior to the event. Generators are NOT allowed.

POSITION -

Every effort will be made to meet with the stallholde's needs, but final acceptance and placement will rest with the organisers.

SITE BOOKINGS -

Please complete application form and return it with a copy of proof of Public Liability Insurance, a copy of your goods and business licence (if applicable) and full payment to Warwick Potters' Association by **5th July, 2024.**

While your form will be received, acceptance is dependent on suitability and availability of site.

PAYMENT OR VERIFICATION OF PAYMENT **MUST** ACCOMPANY APPLICATION FORM
FOR IT TO BE CONSIDERED.

Should you be unsuccessful with your application, you will be advised by the 8th July with your refund.
